The principal also agrees to the transmission of information in accordance with this proxy document to Bioretec Ltd and Innovatics Ltd, as well as between these parties, to be used in connection with the General Meeting and the processing of thereto related necessary registrations.

Shareholders who sign this proxy document as representative of an entity (incl. estate) are required to submit necessary documents to prove the right to represent the entity (e.g. trade register extract, proxy document or a copy of a board resolution). Documents are requested to be attached to these voting instructions. If the documents are not submitted during the registration period or they are otherwise incomplete, the shares of the entity will not be included as shares represented at the General Meeting. Proxy documents in original shall be presented to the Company upon request.

If Shareholder submits more than one proxy, the most recently dated one will be considered. If the dates are the same, the most recently received one will be considered.
